King of the Hill Tournament Rules

1. This is an invitational handicapped and scratch tournament based on weekly youth Bowler of the Week winners in each division for any South Sound USBC Center. Youth bowlers are required to present their South Sound USBC youth card at check-in. League coach or house coordinator should send in list of qualifiers names, sex, average, and average verification sheet to the chairperson no later than the Wednesday before the tournament. **DO NOT CONTACT HOSTING CENTER FOR ANYTHING OTHER THAN DIRECTIONS!**
2. USBC rules and regulations will govern the monthly and Coronation Tournament. USBC youth division code will be enforced and the tournament will be certified (sanctioned). All participants must be current USBC cardholders.
3. Entry fee for the monthly tournament will be \$14.00 (\$7.50 lineage, \$3.00 scholarship funds, \$3.25 prize funds and \$.25 expenses). Any remaining money from prizes or expenses will go into the scholarship fund.
4. Divisions will be based on the averages and are as follows: (one each for boys and girls)

Division 1:	170 and up (Scratch-optional) * All star point
Division 2:	150 and up (Handicap)
Division 3:	126 – 149 (Handicap)
Division 4:	101 – 125 (Handicap)
Division 5:	100 and below (Handicap)
5. Division 1 will be **SCRATCH**. Divisions 2 through 5 will be **HANDICAP** at 90% of 210.
6. A division requires a minimum of three (3) entrants. Boys and girls will bowl in separate divisions. Only if not enough entrants in a division will they be combined. (For example: Division 1 boys and girls combined or bowl in the Division 2 boys or girls handicap. For Division 2 girls combined with Division 3 girls with handicap or bowler has the option to bowl in the boys Division 2). Bowlers will be notified before the tournament begins of any changes. If bowler chooses not to bowl, then he/she will be refunded their entry fee.
7. Monthly winners will be awarded trophies within 30 days of the event. Prizes fund to be returned 100% and trophies will be awarded on a 1:5 ratio in each division. Winners will be entered into the **Coronation Tournament on April 15, 2012 at Pacific Lanes in Tacoma**.
8. Bowlers will compete in the monthly tournament in the division in which they qualified in as a weekly winner. If a bowler qualifies in more than one division, the **HIGHEST** division will be used.
9. If a bowler wins in more than one monthly tournament, the month with the higher division will be used in the Coronation Tournament. If the winner is already entered into the Coronation Tournament, the next bowler in that division will get an invitation to the Coronation. (No monthly trophy). Bowler can only win **ONE TIME** in the same division.

10. In the **handicap divisions**, a total series of three (3) games plus handicap will determine monthly winners. In the **scratch divisions**, a total series of three (3) games only will determine the winner.
11. The highest youth league average based on a minimum of nine games shall be used as of WEDNESDAY before the tournament. If no average, then current average will be used. Exception is October 2011 tournament, in which last year's (2010 – 11) South Sound USBC book average will be used. A bowler who does not have an acceptable average under tournament rules will bowl scratch.
12. **This tournament is NOT a walk-in.** Tournament schedule is as follows:
 (3rd Sunday of each month)

March 18, 2012	Narrows
April 15, 2012	Pacific (Coronation)
13. The SMART Program – Account #9009, will administer scholarship funds. Award fees will be returned 100%.
14. Dress attire must be neat, clean and proper fitting. Collared shirts or USBC official youth jersey and slacks, capris, skirts or skorts must be worn. Skirts and skorts must be to the end of fingers when arms held down to side. Tournament Director must approve any/all exceptions. Tournament Director's decision is final.
15. If there is an error in scoring, contact tournament director or front desk immediately. All other conflicts with the general playing rules must be made to the tournament director no later than 30 minutes after completion of the tournament. The director will decide questionable errors. Any protests must be confirmed in writing to the South Sound USBC Association within 72 hours. Each protest under this rule must be specific in itself.
16. Bowlers arriving late shall begin play and score shall count beginning with the frame that is being bowled. Frames missed shall be credited with a zero. A bowler not present and ready to bowl when it is his/her turn will be credited with a zero for that frame. Check-in at 9:00 a.m., practice will begin at 9:45 a.m. and bowling starts at 10:00 a.m.
17. Coronation Tournament: April 15, 2012 at Pacific Lanes in Tacoma. Invitation only, based on monthly qualifiers.
