#### **Tournament Rules**

1. This Tournament is open to all USBC Youth bowlers. USBC membership cards must be presented at check-in.
2. This event will be **SCRATCH** competition with separate boys and girls divisions.
3. Entry fee will be \$45.00 per entry: \$22.00 lineage, \$21.00 prize fund, and \$2.00 expense fee. Prize fund will be paid out 100% in plaques and scholarships (administered by the SMART program – Acct. #9009).
4. Entries must be postmarked no later than **February 22, 2012** or hand carried and received at the South Sound USBC office no later than 5:00 p.m. on **February 24, 2012**.
5. The first eight (8) games of qualifying will begin **Saturday February 26, 2012 at noon**. Bowlers are expected to have completed check-in and received lane assignments no later than 30 minutes prior to start of bowling. Top 16 bowlers then will return at 9:00 a.m. on **Sunday February 27, 2012** for eight (8) games match play. Winner of match game will receive 30 bonus points. Points will be split in case of a tie. At the completion of match play the top five (5) finishers will then advance to the stepladder championship round to be held 30 minutes after the qualifying round. In this round the 5<sup>th</sup> qualifier will bowl the 4<sup>th</sup> qualifier, the winner bowls against the 3<sup>rd</sup> qualifier and so forth.
6. After the first six (6) games bowled on Saturday the Junior Gold Champion will be posted. If interests warrants, another Jr. Gold Qualifier will be held on Sunday.
7. All awards will be presented within 30 days of tournament completion. First place winners will receive their awards at the SSUSBC Annual Banquet (April 13, 2012 @ Emerald Queen Hotel/Casino, Tacoma, WA). Plaques will be given to the winner. The perpetual trophy will be displayed at the bowling center of the highest placing SSUSBC bowler. Awards will be presented on a 1:5 ratio in all divisions with prize fund returned 100%.
8. Dress attire must be neat, clean and proper fitting. Collared shirts or USBC official youth jersey and slacks, capris, skirts or skorts must be worn. Skirts and skorts must be to the end of fingers when arms held down to side. Tournament Director must approve any/all exceptions. Tournament Director's decision is final.
9. Misconduct/Poor Sportsmanship on or off the lanes during the tournament competition will NOT be tolerated. This can result in disqualification from the tournament and forfeiture of entry fee, position and any scholarship prize. The rule will be enforced at the discretion of the tournament director and committee.
10. If there is an error in scoring, contact tournament director or front desk immediately. All other conflicts with the general playing rules must be made to the tournament director no later than 30 minutes after completion of the tournament. The director will decide questionable errors. Any protests must be confirmed in writing to the South Sound USBC Association within 72 hours. Each protest under this rule must be specific in itself.
